**MANATEE COUNTY MOSQUITO CONTROL DISTRICT RESOLUTION**

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE MANATEE COUNTY MOSQUITO CONTROL DISTRICT, MANATEE COUNTY, FLORIDA, **ADOPTING THE MILLAGE FOR THE TAX YEAR 2017** AND LEVYING AD VALOREM TAXES ON PROPERTY WITHIN THE BOUNDARIES OF THE MANATEE COUNTY MOSQUITO CONTROL DISTRICT FOR THE **TAX YEAR 2017**

WHEREAS, the Manatee County Mosquito Control District, Manatee County, Florida, is authorized pursuant to Section 200.065(2) (d), Florida Statutes, to adopt a Resolution stating the millage rate to be levied regarding Ad Valorem taxes within the boundaries of the Manatee County Mosquito Control District; and,

WHEREAS, in compliance with said statute and after two (2) public hearings regarding the millage rate to be levied, the Board of Commissioners of the Manatee County Mosquito Control District, having heard public comment and considering same, has determined to adopt the hereinafter stated millage rate.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE MANATEE COUNTY MOSQUITO CONTROL DISTRICT, AS FOLLOWS:

Section 1. The rate of taxation for the Manatee County Mosquito Control District, Manatee County, Florida, for the **tax year beginning January 1, 2017, and ending December 31, 2017**, is and shall hereby be fixed at **0.1350 mills** per thousand dollars (\$1,000.00) for general District purposes.

Section 2. The millage rate of 0.1350 is a **16.38% increase** from the rolled-back rate of 0.1160.

Section 3. This Resolution has been publicly read in full prior to its adoption and takes effect upon adoption.

PASSED AND DULY ADOPTED, with a quorum present and voting, this **16th** day of **September, 2016**.
