MANATEE COUNTY MOSQUITO CONTROL DISTRICT RESOLUTION

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE MANATEE COUNTY MOSQUITO CONTROL DISTRICT, MANATEE COUNTY, FLORIDA, ESTABLISHING AND ADOPTING A BUDGET FOR **FISCAL YEAR 2023-2024**; MAKING APPROPRIATION OF DISTRICT FUNDS AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Chapter 200, Florida Statutes, establishes a procedure for the Manatee County Mosquito Control District, Manatee County, Florida, to follow in setting a property tax millage rate and adopting a budget; and,

WHEREAS, the Board of Commissioners of the Manatee County Mosquito Control District has determined that it is necessary and in the best interest of the District to establish a budget for the **fiscal year 2023-2024**.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE MANATEE COUNTY MOSQUITO CONTROL DISTRICT, AS FOLLOWS:


Section 1. **After adopting the millage rate, the Budget for fiscal year 2023-2024 as shown on Attachment "A" to this Resolution, incorporated herein and made a part hereof, is hereby adopted for the fiscal year 2023-2024.**

Section 2. Funds received by and appropriated by the Manatee County Mosquito Control District shall be received and disbursed pursuant to the Budget established in Attachment "A"; and,

Section 3. The Budget established hereby shall take effect on **October 1, 2023**.
