Local Budget Amendment #4 for FY 2017-2018, September 10, 2018

- A) The District will be increasing its Ad Valorem account by \$24,000 and increasing its contingency expense account by \$24,000. The District has received more taxes than budgeted.
- B) The District will be increasing its Interest Earnings account by \$6,000 and increasing its contingency expense account by \$6,000. The District has received more interest than budgeted.
- C) The District will be increasing its Loans account by \$3,400,000 and increasing its Capital Outlay expense account by \$3,400,000. The District will be purchasing two (2) Bell helicopters.
- D) The District will be increasing its Operating Expense account by \$28,500 for attorney fees to purchase two (2) Bell Helicopters and decrease its contingency expense account by \$28,500.
- E) The District will be increasing its Repairs & Maintenance account by \$15,000 and decreasing its contingency expense account by \$15,000 to cover additional repairs expected in September.
- F) The District will be increasing its Misc. Supplies account by \$10,000 and decreasing its contingency expense account by \$10,000 to cover remaining miscellaneous expenses in September.
