**Manatee County Mosquito Control District**  
**Local Budget Amendment #4 for FY 2019-2020, June 10, 2020**

This budget amendment is needed for the following reasons:

Increase Ad Valorem taxes by \$15,445.13 as the District is receiving more taxes than budgeted. With this additional income, the District is increasing its Repairs & Maintenance account by \$15,445.13 to cover unexpected helicopter repair expenses.

Increase our Repairs & Maintenance account by an additional \$20,000 and reduce Contingency by \$20,000 for unexpected necessary repairs and maintenance.
