**Local Budget Amendment #5 for FY 2019-2020, September 10, 2020**

This budget amendment is needed for the following reasons:

Increase Ad Valorem taxes by \$2,315.78 as the District is receiving more taxes than budgeted.  
Increase Interest Earnings by \$5,400.00 as the District is receiving more interest than budgeted.  
With this additional income, the District is increasing its Capital Outlay Account by \$9,995.00 to cover an unexpected larviciding equipment purchase that needed to be made. The District is also increasing its Publication and Dues account by \$4,153.60 and reducing contingency by \$6,432.82.
