Local Budget Amendment #2 for FY 2020-2021, March 10, 2021

The District is increasing Account 364 "Equipment and/or Other Sales" by \$6,535.00 to account for unexpected revenues in surplus property and placing this additional money into Account 89 "Contingency".

The District also observed unexpected expenses in Operating Expenses (Account 30) of \$300.00 for the annual Audit/Actuary Fees. This will be drawn from Contingency.

The District is increasing Account 60 Capital Outlay by \$21,362.52 for the purchase of the following items:

4 Electric Atomizers (helicopter adulticiding)	\$11,876.52
1 Hydraulic "Mini-Mule" (purging helicopter hydraulics)	\$5,736.00
MapVision/GIS Database (increase in expense)	\$3,750.00

The sub-totals of \$21,362.52 and \$300.00 summing \$21,662.52 will be all reduced from Contingency.
