Manatee County Mosquito Control District
Local Budget Amendment #4 for FY 2021-2022, August 10, 2022

The District is increasing Ad Valorem revenue by \$1,214.27 as we have received more income than budgeted. We will use this additional revenue towards a capital expense.

The District is increasing Equipment and/or Other Sales by \$14,985. The District received unexpected income from equipment sales (sale of truck). We will use this additional revenue towards a capital expense.

The District is increasing its Publications & Dues account by \$3,211.28. The District spent more on publications and dues than expected.

The District is increasing Capital Outlay by \$36,016. The District would like to purchase a forklift which is needed for facility operations.

We are reducing contingency for this capital expense by \$23,028.01.
