Local Budget Amendment #4 for FY 2022-2023, June 9, 2023

One of the District's vehicles was involved in an accident which resulted in totaling of the vehicle. The District received a settlement check in the amount of \$21,342.45; however, the District did not anticipate selling any vehicles and had budgeted \$10,000.00 in Equipment/Other Sales. Therefore, the District is increasing Equipment/Other Sales by \$11,342.45 to account for the settlement funds received. The District is applying the \$11,342.45 to contingency.

The District needed to purchase two new ice machines which was not anticipated when preparing the budget. Therefore, the District is adding \$11,157.10 to capital outlay and using contingency funds to cover these purchases.
